E. Pinlac states that under the California Labor Code, employees must reimburse for any necessary jobs. Because of shelter-in-place, there has been a strain on people's internet as well as cell-phone use. I have the total cost and the area I plan to take the budget from. The cell phone part will end in October since there is an application that staff members have downloaded. Once someone calls the office line, it is transferred to our cell phones. The internet service will be paid for until the end of the pandemic. I have budgeted until the end of the fiscal year, which is June 30th. The total amount is \$5, 970.00 and my proposal is to place it under supplies and services. This budget is mainly composed of office supplies and water service. The number is double what we expected and there is additional money coming in. If more supplies are needed, the budget can be reallocated during the mid-year budget review.

VII. NEW BUSINESS ITEMS:

A. DISCUSSION ITEM - Neolth Student Ambassadors


The Board of Directors will engage in a discussion with a Mental Health Ambassador for the company Neolth.

Arielle Lingat states that she is the School Outreach Subcommittee leader for Neolth. Neolth is a company that has a target of improving mental health, particularly for high school and college students. Jasmine Brownlee states that the company has its own digital platform to help students. Our committee strives to seek awareness for student mental health. Ninety-one percent of students feel overwhelmed and according to the CDC, one out of four students are suicidal. Fifty percent of mental health conditions begin at the age of fourteen and most are left untreated. Suicide is left the highest leading cause of death in fifteen and nineteen-year-old students. Mental health influences the entire world and different cultures have their own definition of mental health and what they consider an illness. The meaning of an illness is often associated with deep seeded attitudes and beliefs that a culture holds whether an illness is real of imagined. This concept can be viewed as a popular misconception. Stigma can also play a major role in a discussion on mental health. The World Health Organization describes stigmas as a mark of shame, disgrace, or disapproval, which results in an individual













being rejected, discriminated against and excluded from participating in a number of different areas of society. A stigma in one's culture can demonstrate heightened levels of anxiety. The stigma, various opinions, and perspectives on mental health can play a large role in an individual's coping style, treatment and family support. Johnny Garcia-Ventura states that since everyone is a student in an academic environment, it is important to discuss how academics and mental health relate to each other. We will discuss how mental health influences academic performance, the different pressures students face in school, and how school influences mental health. In a study done by the Suicide Prevention Resource Center, they noted that depression is associated with lower grade point averages and constantly occurring depression and anxiety can increase this association. Additionally, depression has been linked to dropping out of school. Other factors such as attention deficits and cognitive disturbances can affect scholastic development. Maintaining mental health is important, especially in regards to education. **Karen Kwan** states that school is stressful. There are many things that drive school related stress. We spoke to Dr. Claire Wheeler about some of the issues we face. It is a negative spiral for the academic system. Parents, and teachers are placing negative pressures on students. **Trisha Venkat** states that there are many ways in which school can affect mental health. Studies have shown that there is an upper dissociation between higher education and mental health issues. Psychological distress amongst students rises steady during the first semester of college and remains elevated in the second semester. Students are also exposed to different environments where social pressures are faced. At every level of education, students may face the need to fit in. School has been shown to affect physical health and lack of sleep has been a major health concern with students. Lack of sleep has been correlated to various mental health problems such as depression, anxiety, stress, and lack of focus. Monique Quillopo states that a major social relationship that most people take part in is with friends or significant others. A commonly observed trend among those with declining mental health is that social networks and groups were significantly reduced during this time. Many seek family members as a primary source of support. Since friendships become limited, those that suffer from poor mental health, tended to deal with social situations less effectively. This may be due to a fear of rejection from others or the stigma of mental health. In regards to relationships with significant others, stress and stigma were seen to be reciprocated from both partners. One partner would attempt to conceal their symptoms and causes stress and tension. The other partner would feel confused or frustrated by the inability to help. Mental health within the LGBTQ + community is an important conversation to have. Within the community, it is shown that mental health illnesses have been prevalent. Transgender students show elevated rates of mental health disorders. Twothirds of transgender students suffered self-injury and more than one-third attempted suicide.









More than fifty percent of bisexual students reported suicidal ideation and self-harm along with twenty-five percent that attempted suicide. Arielle Lingat states that mental health plays a huge role in family relationships. This is something to discuss, since most students are using online learning platforms. Studies have verified that one-half of family members, particularly parents, develop large social and economical impact such as inconsistencies in sleep and depression. The unpredictability has placed stress on families as well as individuals. Families believe that they are to blame for their child's declining mental health. Parents stated that they have been obligated to resign from their jobs and refrain from pursuing other recreational events as a result of tending to their child's mental health needs. **Arielle Lingat** states that mental health may feel like an individual battle. Loved ones can play an important role of improving mental health. Something that we discovered through Mental Health America and the papers that have been read is that support is key. Parents can continue to watch their children and help them seek assistance from their pediatrician or mental care professional. Monique Quillopo states that treatment and care can come from different outlets. There are different resources such as school counselors, support groups, and therapists. As Neolth ambassadors, we would like to introduce our resource to promote mental health. Neolth is an online platform that offers on-demand and individualized mental health support to students. It offers self-guided activities such as meditation, journaling, cognitive behavioral therapy, and other activities to help support students. Additionally, there is a video library that provides access to different professionals and their thoughts on different topics. Through this platform, we want students to feel empowered to manage their own stress and health through technological devices. There is a video that shows students' review of Neolth. We hope that you all would look into the platform to gain a better idea of Neolth and the services it provides. We offer a referral code for anyone that signs up during this meeting. The program is free for two months. Hopefully this platform will be of use to everyone. With upcoming finals and stress, we want to emphasize how important mental health is and with Neolth, we hope it is a useful resource. By doing these presentations, we hope to break the stigma and foster positive mental health within students. A. de Leon states that mental health is important for students, especially during the pandemic. Why are you all passionate about mental health? **Arielle Lingat** states that mental health impacts people every day and with the many things going on in the world, we wanted to bring awareness to self-care and open up discussion. Monique Quillopo states that she has gone through her own personal mental health illness. Four years ago, I was diagnosed with major depression disorder and it was difficult. I am Filipino and there is a stigma on mental health. My parents did not understand my situation and I did not have a close relationship with them. Over the course of time, communicating with them helped them to understand that mental health is









real. I want to ensure everyone that they are not alone. I would not expect to be where I am today if it was not for the help I received. **E. Pinlac** asks how the individual and school memberships work. **Arielle Lingat** states that Neolth is projected towards individual memberships and the other membership is based on school outreach and networking. Even though we work with schools, each account is individualized and customized.

Monique Quillopo states that after the free trial, there is a monthly subscription, but student discounts are offered. I attend East Bay and I planned to reach out to the Dean or director of Health Services to see if there is interest in adopting the platform to better support students. Once the platform is adopted, students receive the help for free. As apart of East Bay, I am working to make the connections to better support everyone.

Pamela Sanchez and I will on the panel and the President will accept our CFA chapter president. The meeting will be the Wednesday after Thanksgiving. The town hall is to talk about finishing up the semester and what is happening within science.

M. Hinrichs states that December 4th is orientation for incoming students. There are over four hundred students registered for orientation. It would be perfect to ASI on Zoom during the virtual resource fair or during the Pioneer Zoom session the following week. I will email the information to everyone for sign up.
