#### A. DISCUSSION ITEM – Memorial Bench


The Chair will give updates regarding the 2020 Memorial Bench project.

**A. Miralles** states I went to the office hours of the construction management and he was super happy to work with us. However, his only concern is finding someone to help us due to them having their own projects to work on and many of the students graduate in May. Realistically he stated that it would be done by next fall if we did not have a design. Therefore, if we come up with a design then it should not take more than a month to complete but I would need to get cleared by facilities first. I reached out to facilities and they told me I need to reach out to VP of Student













Affairs, which is Suzanne Espinoza, and she is going to reach out to someone else. Daniel from facilities did state that if we do something external then it would need to be consistent with what campus already has. I have pictures of how the some of the benches on campus look like and we would not be steering away from the design. I am going to see if we can do a different design. W. Torre ask if the bench were to be consistent with the others, are we able to make it distinctive? A. Miralles states I am not sure I am still waiting on the answer. **K. Cutting** states the big red chairs are not the same, therefore, I would not worry too much on keeping everything the same. Especially if you are deciding to put the bench in a certain location away from other benches. A. Miralles states I will try to have the bench look unique and it will have the plaque we discussed. The construction manager also suggested to put their plaque on the back of the bench in order to show student involvement. After we clear it with facilities, I can attend one of his classes in order to recruit students who would want to be involved in creating the bench. G. Angkaw states if we can choose a date in order for us to chose which design and where the bench will be located. A. Miralles states next week, we can do a walk around campus in order to choose the location of the bench. When I was walking around campus, I started to get overwhelmed by how the bench might be positioned and the location.

The Chair will give updates regarding the installation of StepNpulls in Concord Campus bathrooms.










**A. Miralles** states I reached out to Daniel, since we were already talking about the bench. Daniel stated that our idea is not ADA compliant and I asked him if he can explain why not. Daniel stated that ADA compliance needs a clear path to get through the door and this will block the entrance. We also cannot provide something that many disabled people cannot reach. **K. Cutting** states that Daniels concern is more with the doors that do not have buttons. However, you can install the StepNpulls in the bathrooms that do not have the buttons to open the bathroom door. Was the StepNpulls ADA compliant? W. Torres states that on the website it does state it is ADA complaint. A. Miralles states I did feel dismissed by Daniel. I also want to ask W. Torre if he can research if this has been done on other campuses and if they do have, we need to ask why we cannot have it. **K. Cutting** states that this product was in Sunny Valley mall and if they were able to comply with ADA then we can as well. **A. Miralles** states what if they make the bathroom door button. **K.** Cutting states you will not be able to afford that as opposed to this product. **D.** Ramos ask what does Daniel means by when the handicap cannot reach the product? A. Miralles states we cannot provide a service that does not serve disabled people. This benefits many people, but I will understand if this do not allow disabled people to not use these bathrooms. **D. Ramos** states if we can ask Daniel what his definition of ADA is that way we can accommodate to his standards. K. **Cutting** states you can also approach Daniel by showing him what you are showing us in order to get a better understanding. A. Miralles states I have met some resistance due to people thinking I am young and not taking me seriously. Would K. Cutting help me to help him understand the reason for the StepNpull? C. Ruiz states you can pitch yourself as a nursing major as we all are and sell it as a health issue. The ideal situation is to get the ADA push button; however, it is expensive, and this idea is a good compromise. This will be able to serve the majority of the Concord students. **K. Cutting** states we can talk to Dr. Phelps and see if he can get other people onboard with the idea. A. Miralles states I also have the contact of, David Miller, another facility member and I can also ask him for a second opinion and will be going through other channels. Who do you think will be more effective in helping us? **K. Cutting** states we should discuss with Dr. Phelps in order for him to be involved in this situation. W. Torre states I found the department of labors code and standards. I will also include this information in the document in order for you to use it as a talking point.


# B. DISCUSSION ITEM – **Sock/Clothing Drive**


