  - A. DISCUSSION ITEM: **Seed Funding Requests**  
The Finance committee will review the applications of seed funding requests and ensure they meet the requirements.  
**N. Sharma** goes through the seed funding request submitted by Karrington A Hendrix of the Stigma Free Club. The date of the application is February 13<sup>th</sup>, 2024. They have submitted an invoice \$170.00. She states that Stigma Free Club is eligible for seed funding as the application abides by ASI policy for seed funding.



**B. DISCUSSION ITEM: Club Funding Requests**

**P. Ayyagari** proceeds through the club funding request submitted by Rin K Anderson representing Queers United Club. The date of the application is February 12,2024 and the name of the event is ‘Queers United Presents... Queer-Coded’ which would be held on March 12<sup>th</sup> 12:15 PM to 2:00 PM. They have an invoice of \$308.00 for food and another invoice of \$60.00 for miscellaneous items. She states that Queers United is eligible for club funding as the application complies with ASI policy for club funding. **R. Pagadala** goes through another request submitted by Jonathan Michael Crescenzo representing The Bad Designers Club. Their application was submitted on February 14, 2024 for the event ‘Bad Designer Club Meeting’ which would be conducted on February 23,2024. They requested for Food with an invoice \$109.00. She states that the club is ineligible for funding since they did not apply 30 days prior to the event. **V. Myneni** inspects the club funding request submitted by Israel Sanchez representing Information System Club on February 19<sup>th</sup>,2024 for the event ‘Information Systems Club x ASI Headshot event. This event will be held on March 19<sup>th</sup>,2024. They are requesting \$450.00 for the photographer and have an invoice \$450.00. He states that their application conforms to the ASI Policy. **N. Sharma** examines another request submitted by Jaylin M Santos representing STEM Inclusivity on February 20, 2024 for the event ‘Speed-Friending’ which would be held on March 26<sup>th</sup>, 2024. They have an invoice of \$322.36 for food and \$327.39 for miscellaneous supplies which sums up to \$649.75. They requested for an amount of \$649.75. She states that the STEM Inclusivity club is eligible for club funding as the application follows the ASI Policy. **P. Ayyagari** inspects the final club funding request submitted by Karrington A Hendrix representing Stigma Free Club on February 18<sup>th</sup>,2024 for the event ‘Charge Up for Finals with a Relaxing Sound Bath Session’ which would be conducted on April 17<sup>th</sup>,2024. There are requesting for \$600.00 and have an invoice \$600.00. She states that the application is eligible for club funding as the application observers ASI Policy.
