

## **BOD 2015-16 – 7R Resolution on the Board of Directors Term Change**

**WHEREAS**, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of about 15,000 students; and

**WHEREAS**, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students; and

**WHEREAS**, the role of ASI is to facilitate participation across a spectrum of fields relating to the promotion of student life on this campus; and

**WHEREAS**, CSUEB is committed to the Eight Shared Strategic Commitments that values, honors, and respects diversity by responding to the backgrounds and interests of our diverse community and promoting their academic, professional and personal development<sup>1</sup>; and

**WHEREAS**, CSUEB ASI is growing as an organization and is creating more positions; and

**WHEREAS**, the CSUEB ASI Board of Directors is composed of 14 Board Members; and

**WHEREAS**, the current Bylaws state that Board of Directors shall serve for a one (1) year term of office, commencing at 12:00pm (Noon) the last day of June and ending at 12:00pm (noon) the last day of June of the following spring term; and

**WHEREAS**, in Fall of 2018 we will be converting to a semester-wide campus and school will end in May, rather than June; and

**WHEREAS**, the Board of Directors must begin their terms the month after school is over; be it therefore

**RESOLVED**, that the ASI Board of Directors begin their terms earlier, in order to reflect a semester-wide calendar; and let it be further

**RESOLVED**, that the students of East Bay partook in a Special Elections that allowed them to cast their vote on the term change of the Board of Directors; let it be further

**RESOLVED**, that the students voted yes to the term change of the Board of Directors; let it be further
