

BOD 2019-20 – 16R
Resolution in Support of Proposition 13

WHEREAS, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 16,000 students; and

WHEREAS, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students; and

WHEREAS, the CSUEB ASI policy agenda advocates for student success and equity as well as basic needs

WHEREAS, Prop 13 requires “that residential, commercial, and industrial properties are taxed based on their purchase price. The tax is limited to no more than 1 percent of the purchase price (at the time of purchase), with an annual adjustment equal to the rate of inflation or 2 percent, whichever is lower”

WHEREAS, ASI supports CSSA Resolution In Support of The Public Preschool, K-12, and College Health and Safety Bond Act of 2020 (Proposition 13) and CSSA 2019-2020 policy agenda “Ensure the CSU is accessible, affordable, and sustainable”; and

WHEREAS, the CSSA resolutions states that the Board of Directors “voted to support AB 48 in the 2019 Legislativesession, the bill that placed Proposition 13, a \$15 billion statewide K-12 school and college facilities general obligation bond on the March 3, 2020 ballot”; and

WHEREAS, if Proposition 13 passes, the CSU system will receive \$2 billion in improving its infrastructure to “ensure safe and modern facilities for its students, faculty and staff”, and

WHEREAS, if Proposition 13 passes, we encourage CSUEB to used the funds to improve our current infrastructure and create more affordable on-campus living

RESOLVED, that ASI supports Proposition 13- the Public Preschool, K-12, and College Health and Safety Bond Act of 2020

RESOLVED, that copies of this resolution be distributed to the Office of the President, Office of the Vice President for Student Affairs, Provost office, and any other relevant parties.


