

## Senate 2019-20 – 2R Resolution of the Preservation of Title IX's Rights

**WHEREAS**, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 16,000 students; and

**WHEREAS**, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students<sup>1</sup>; and

**WHEREAS**, the purpose of the ASI Senate is to serve as the governing body of the students of CSUEB as the ASI Senate, to advocate the causes of CSUEB students, and to provide programs and services designed to meet the varied needs of CSUEB students<sup>2</sup>; and

**WHEREAS**, the ASI Policy Agenda of 2019-2020<sup>3</sup>, Priority #1: Student Success and Equity, is to "enable student academic success & equity that is geared towards improving academic success, and Priority #2 is to "ensure that students are receiving further support in regards to their basic needs and having access to mental health services;" and

**WHEREAS**, "the CSU was the first university system in the country to appoint a dedicated systemwide Title IX Compliance Officer to actively address issues related to sex discrimination and sexual violence<sup>4</sup>."
