WHEREAS, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 16,000 students; and

WHEREAS, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students; and

WHEREAS, the CSUEB ASI Policy Agenda for 2021-2022 states that "basic needs, such as food, financial, and housing security, will be a priority," and


WHEREAS, "Young people have a massive stake in the decisions that shape the country. Nearly all issues affect youth, and many affect youth differently or uniquely: education, healthcare, the environment, immigration, housing, gun violence, and foreign policy that may send them or their peers to war. When young people vote and participate in civic life, they can bring valuable perspectives to these issues and play an active role in shaping their future. If youth are excluded or do not participate, our democracy is not truly representing all people and not meeting its full potential," and

WHEREAS, the For the People Act advocates "to expand Americans' access to the ballot box, reduce the influence of big money in politics, strengthen ethics rules for public servants, and implement other anti-corruption measures for the purpose of fortifying our democracy, and for other purposes," and
