Resolution in Support of the Federal For the Higher Education Budget Trailer Bill

WHEREAS, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 16,000 students; and

WHEREAS, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students; and

WHEREAS, the CSUEB ASI Policy Agenda for 2021-2022 states that "We are focused on providing accessible and equitable resources for all students, particularly students of color or those often underrepresented." and

WHEREAS, the Higher Education Budget Trailer Bill advocates for the implementation of "significant California Comeback Plan investments in college affordability and access — including expanded student financial aid, education and training grants for workers displaced by the pandemic, transfer pathways for community college students and college savings accounts for low-income and underrepresented public school students."² and

WHEREAS, "Year-round financial aid can boost enrollment and credit accumulation in the summer and help students accelerate their studies." and

WHEREAS, the Higher Education Budget Trailer Bill will work to "create more equitable and streamlined pathways from school to career, the budget trailer bill establishes a Learning-Aligned Employment program at the UC, CSU and CCC to help underrepresented students with

financial need gain relevant work experience, promoting long-term employment opportunities."4and

WHEREAS, "We must encourage accreditors to focus on student outcomes, raise the bar for quality, and promote transparency. Accreditors must offer new levels of transparency and quality assurance based on outcomes—not just inputs. We must encourage institutions to improve their performance by recognizing and rewarding colleges with strong student outcomes, especially with the neediest students, and incentivizing underperforming colleges to improve. All institutions and systems must do more to control costs and innovate to make degrees more affordable, and focus on their success rate with students who have traditionally been least likely to complete their programs and degrees."5 and

WHEREAS, "The state's spending plan will provide \$350 million in one-time Proposition 98 funds, available over five years, for programs that recruit and support teachers in specific fields where shortages are occurring, including special education, bilingual education, science, computer science, technology, engineering, mathematics, transitional kindergarten and kindergarten. The allocation also supports efforts to recruit and retain a diverse teacher workforce."6and

WHEREAS, "Special education would receive a cost-of-living adjustment of 4.05 percent in the budget, which channels \$396.8 million in ongoing Proposition 98 funding to increase the statewide base rate to \$715 per student." be it therefore

RESOLVED, CSUEB ASI extends our support for the Higher Education Budget Trailer Bill as students with health risks will be able to get a valuable education through independent learning

RESOLVED, ASI encourages the California State Student Association to extend their body's support for the bill, and encourage the rest of the California State University system to follow; and let it be finally
