

## BOD 2021-22 – 1R Resolution to Renew the Social Justice Ad Hoc Committee Resolution

**WHEREAS**, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 14,000 students; and

**WHEREAS**, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students; and

**WHEREAS**, CSUEB's Shared Strategic Commitments includes being dedicated to "enhance our inclusive campus, responding to the backgrounds and interests of our diverse community and promoting their academic, professional and personal development;" and

WHEREAS, the ASI Bylaws, Article IX, Section 3, states "The Board of Directors shall have the authority to establish such Ad Hoc committees as may be necessary. All meetings of the ad hoc committees shall be conducted in accordance with the provision of the California Nonprofit Public Benefit Corporation Law. The Board of Directors shall define membership of each ad hoc committee. The President of the Board of Directors shall appoint the chairperson of each ad hoc committee. As per all other ASI committees and University Wide Committees, there must be an approved Committee Code prior to the commencement of committee business. Quorum (50%+1) must be present at all meetings of the committee."; and

WHEREAS, ASI is committed to serving the diverse needs of our student population, and to addressing issues pertaining to social justice and equity; and

**WHEREAS**, the Social Justice Ad Hoc Committee provides an opportunity for CSUEB ASI to gather more diverse voices, and ensure that any issues pertaining to social justice and equity are properly addressed; and

**WHEREAS**, there is a need for the Social Justice Ad Hoc Committee to continue, and for ASI to provide student opportunities for leadership; be it therefore

**RESOLVED**, that ASI shall renew the Social Justice Ad Hoc Committee for the 2021-2022 academic year; and let it be further,

**RESOLVED**, that the committee code shall be set for the Social Justice Ad Hoc Committee (SEE ATTACHMENT 1); be it therefore

**RESOLVED**, that copies of this resolution be distributed to our University President, the Vice President for Student Affairs, Chief Diversity Officer, Coordinator for the Diversity and Inclusion Student Center, East Bay Today, Academic Senate, the Pioneer, digitally to all students, and any other relevant parties.

#### **Social Justice Ad Hoc Committee Code**

#### 1. Name

This committee shall be known as the Social Justice Ad Hoc Committee. This committee is an ad hoc committee of ASI.

#### 2. Purpose and Duties

The Social Justice Ad Hoc Committee will be dedicated to representing the diverse community at California State University, East Bay and tackling social issues that may pertain to students on campus in combination with ASI. The purpose and duties of the Social Justice Committee shall be to:

- Provide accurate and diverse representation of California State University, East Bay within ASI
- Engage in dialogue with ASI about current social issues that relate to the student body and the greater community
- Ensure that student voices on social issues are heard and the resources necessary in order to meet student needs are implemented

#### 3. Membership

The Vice President of University Affairs will chair the Social Justice Ad Hoc Committee and shall be a voting member.

Additionally, other voting members of the Social Justice Ad Hoc Committee will include:

- Executive Director shall be a non-voting advisor
- University Diversity Officer shall be a non-voting advisor
- Director of Legislative Affairs
- Senator of Diversity
- Six to Eight (6-8) students-at-large recommended by the Chair and appointed by the Personnel Committee shall serve as voting members (one of which shall serve as the Vice Chair of this committee).

#### 4. Quorum

Fifty percent of the membership shall constitute a quorum. Quorum must be present at all meetings of the committee, and must include either the Chair or the Vice Chair of the Committee must be present for the meeting to proceed.

### 5. Meetings


The Social Justice Ad Hoc Committee shall meet as needed during the Academic year. A calendar of meeting dates, agendas, and minutes will be posted and be available at all times. Meetings shall be conducted in accordance with Robert's Rules of Order, the ASI Standing Rules, where applicable, and the Education Code, Sections 89920 through 89928.

#### 6. Enactment

This Social Justice Ad Hoc Committee shall become effective upon final passage by ASI Board of Directors, and upon the signature of the ASI President/CEO of the ASI Board of Directors. The Committee Code supersedes all previous legislation pertaining to this body and any such legislation currently in effect is hereby repealed.
