In Memoriam: Dr. Jay L. Tontz

Dr. Jay Logan Tontz, former Dean of the College of Business & Economics, passed away on November 14, 2019, at the age of 81 years old.

In 1969, Dr. Tontz started at California State University, Hayward, as an Economics professor then became the Chairman of the Economics Department from 1972-73.

In 1973 he became the Acting Dean and then became the third Dean of the college from 1974 until 2003.

Serving for 30 years, Dr. Tontz was the most tenured Business Dean in the U.S. at the time.

He was instrumental in the development and growth of the College of Business & Economics and continued teaching as a professor emeritus for CSUEB until 2008.

Economics was Dr. Tontz's primary research focus, and his work also extended into establishing American MBA programs in Moscow, Austria, Hong Kong, and Singapore.

In a 2007 interview from Cal State East Bay Magazine, Dr. Tontz spoke of the economic potential in the Bay Area. "The Bay Area, specifically the East Bay, is a more dynamic economic engine than the rest of the country for a number of reasons. We have much better climate. We don't have snow days that shut us down. In terms of economic climate, we have a much larger concentration of venture capital here, therefore, much more support for the start up and growing of new technology and new industries."
