## Educational Materials Developed in Community-Based Participatory Research

**PHASE 1.** Culturally sensitive depression education and assessment materials for the Chinese immigrant community were developed in 2012-13 with a team of health and mental health professionals, social workers and community members. The Okura API Mental Health Leadership Foundation (\$10,000) and CSUEB Department of Social Work (\$18,000) provided funding for the project. The team developed the materials based on their clinical experience and the research literature. The materials were disseminated to organizations serving Chinese immigrants locally and in other states and evaluated in small educational workshops held in local community organizations during 2014-15. **PHASE 2.** Four depression and suicide risk assessment videos for training primary care physicians who serve Chinese immigrants are being developed in 2016-17 with a team of physicians and mental health professionals. The Chinese Community Health Care Association (\$6,750) and Portsmouth Square Plaza Parking Corporation (\$2,600) fund this project. The team developed scripts and shot the videos in 2016. Each video shows a physician interacting with a patient, with each of four patients presenting different symptoms and styles of expression. The videos, in Cantonese with Chinese and English subtitles, will be produced and disseminated to private and public medical clinics in 2017.
